

**Minutes of Meeting held May 11, 2010**

Meeting of the Board of Sewer Commissioners held at the Water Department, 3 Old Meadow Road, Spencer, MA.

Meeting was called to order at 5:05 pm.

1. Read and accepted minutes for April 13, 2010.
2. Signed monthly commitment for septage fees.
3. Superintendent Mark Robidoux Review:
  - Monthly Operations Reports
  - Monthly Monitoring Reports
  - SOP repairing damaged sewer pipe letter
  - Loan rate for FY11
4. Due to Olde Sibley Farms properties bankruptcy and expired sanitary sewer flow capacity reserve, the reserve fee is forfeited. The Sewer Commissioners would like a letter sent to Mary Barrell about putting a lien on Olde Sibley Farm for \$1,426.63 for unpaid engineering expenses.
5. Mark informed the Sewer Commissioners that Pat Gallant (Bixby Trail Estate) told the Town Administrator that he will sue the Town if he loses a buyer for the property.
6. Frank White signed the Waste Management agreement for fiscal year 2011 Non-Hazardous wastes disposal.
7. Reviewed Spaducci account history. Mr. Spaducci wants late charges removed because he did not get a bill, but he pays bills late. The Sewer Commissioners decided against abatement.

8. The Sewer Commissioners decided not to have a meeting in June, but would like to reschedule July meeting for July 6, 2010. Also, the agenda for the meeting will change starting July 1, 2010.
9. The Sewer Commissioners discussed a sewer moratorium due to our annual average influent flow was exceeded 2 years in a row. A public hearing may be required for this. No decision was made at this time.
