1. The Chair opened the meeting at 7:01 pm

2. General Board Discussion/ Board Liaison Reports

Ms. Vivier stated the site walk for North Brookfield Solar is tomorrow at 11:00 am. Ms. Vivier stated if the Board would like to go, please arrive at the Town Hall at 10:45 am.

3. Town Planner Report

Ms. Vivier did not provide a report.

4. Citizens Input

Matthew Defosse, 7 Paul's Drive, read a narrative regarding North Brookfield Solar. Mr. Defosse asked the Board if approving a slope waiver was the best decision and encouraged the Board to plan a site visit. Mr. Defosse mentioned the signs located on the property, and stated the Megawatts on the sign are different from what was approved originally by the Board. Mr. Defosse expressed concerns regarding how many different solar companies have boughten the project over time.

Mr. Ceppi stated that the efficiency of the panels has improved since the Special Permit was approved years ago.

Roger Foss, 39 Gold Nugget Road, handed the Board a narrative regarding the Community Preservation Act. Mr. Foss stated the Act is Article 20 at the Annual Town Meeting and would need a second vote at the Annual Town Meeting in the fall. Mr. Foss explained the Act which would add a 1.5% surcharge on tax assessments after the first \$100,000. Mr. Foss stated low-income families and Chapter 59 would be exempt from the surcharge. Mr. Foss stated if the Act is passed a committee would need to be put in place which would consist of a member from the Planning Board.

Mr. Jeffrey Bridges, Town Administrator, stated the percentage for the surcharge is 1% on the town warrant.
